


This document is to serve as the Annual Benefit Report required by the Minnesota Secretary of State for the reporting period of 1/1/2015 – 12/31/2015.


With what regard to the period covered by the report, a narrative description of;

- (i) The ways in which the corporation pursued and created the specific public benefit in its article? Electric Machete Studios, SBC has pursued the specific public benefit by curating gallery shows on and offsite, hosting community art events and teaching artist lead workshops. Artists also performed at several local events.
- (ii) The extent to which that specific public benefit purpose was pursued and created? Electric Machete Studios, SBC was incorporated on 10/07/2015 and since that time has organized and curated 2 on site gallery shows, a community youth run focused on education surrounding water rights and the health of the waters. We also hosted 2 community art events. Offsite all 6 off our collective members performed at several local events and 1 of our artists hosted a solo gallery show in downtown St. Paul.
