Mission # 1 was partially achieved as we had the aircraft on display with the Commemorative Air Force (A non profit) at the South St Paul Airport. Museum visitors were able to view the aircraft and docents discussed the aircrafts history and how it is being used to honor our veterans. Mission # 2 was not achieved. Mission # 3 was definitely achieved as we have been continuously working on the aircraft to return it to flight. Our goals to achieve our threefold mission were hindered by setbacks in getting the aircraft flying. This was due to the owner having military commitments out of state that too him away from working on it. We also had issues with the paint process we are using to finish the aircraft. We anticipate our goal to achieve all three missions will be achieved in 2016 as we plan to have the aircraft flying in the next few months. Overall this setback is minor as we have been working on returning the plane to flight for almost five years.
