Once the articles have been filed and returned to you, your organization's application for tax exempt status can be sent to the IRS. Article III - Duration

The limited liability company has a perpetual duration unless stated otherwise.

Article IV - This Nonprofit Limited Liability Company is subject to Minnesota Statutes, section 322C.1101.

A limited liability company is a nonprofit limited liability company if it is organized under or governed by this chapter and its articles of organization state that it is a nonprofit limited liability company governed by this section.

Article V – Organizers (Required)

Only one organizer is required. An organizer must be an individual 18 years of age or older. List the name and complete address for each organizer. A signature is required for each organizer or by an Authorized Agent (The signing party must indicate on the document that they are acting as the agent of the person(s) whose signature would be required and that they have been authorized to sign on behalf of that person(s).) Reporting Business Ownership Information
