Wellbeing Linker (Operating name for Well Linker)

Growing numbers of people in the United States seek out holistic therapies to augment or replace conventional medicine, but don't have a trusted source for information about therapies or providers. Wellness Linker is a web-based tool that allows people to share their stories about their experiences with holistic therapies, thereby creating a community space for healing and learning. Over time, this sharing will reveal patterns of therapy success and failure, which will be collected in Wellbeing Linker's database. This information will both assist individuals searching for healing alternatives as well as provide direction for future clinical research about promising therapies.

History of Wellbeing Linker

- Incorporated on January 2, 2015, as a Minnesota Public Benefit Corporation under the name Well Linker.
- Founders: Trudy Ohnsorg and Ellen Benavides
- After years of working as an expert in the field of evaluating peer-reviewed medical literature to
 evaluate whether the treatments and therapies studied were safe and effective, and finding a gap
 in the knowledge base about holistic therapies, Trudy Ohnsorg founded Well Linker (now
 operating as Wellbeing Linker) to help people share their stories about their experiences with
 holistic therapies. Trudy was joined in this effort by Ellen Benavides, an independent health
 care consultant.

With regard to the period covered by this report, January 1, 2017 to December 31, 2017, Wellbeing Linker pursued the specific benefit purpose stated in its articles of incorporation in the following ways:

- Well Linker has changed its operating name to Wellbeing Linker.
- Wellbeing Linker has met quarterly with its Trusted Advisors team to help guide the organization.
- Wellbeing Linker has met with several individuals and organizations to share its concept and seek advice regarding the development of the organization.
- Wellbeing Linker has surveyed holistic practitioners and potential clients about the concept and their interest in using the website.
- Wellbeing Linker has updated its descriptive website for the organization, and established its own URL: www.WellbeingLinker.org.
- A list of prospective funders, partners, and/or sponsors is being developed.
- Wellbeing Linker is in discussions with a potential strategic partner regarding the development of the business model and minimum viable product.

 Wellbeing Linker is currently in the planning and development stage. Considerable effort is being invested to create a model that will best meet the needs of the consumers and providers that Wellbeing Linker seeks to serve.
