## Mobility 4 All GBC Annual Benefit Report 2017

This certifies that the Mobility 4 All's board of directors has reviewed and approved this report for calendar year 2017. The Mobility 4 All's board of directors has chosen the *B-Labs Impact Assessment* as the third-party standard for Mobility 4 All GBC, pursuant to clause (2), item (i). The board has determined that B-Labs, the organization that has promulgated this third party standard is independent.

## Mobility 4 All's Creation of Public Benefit

(A) How the corporation has pursued general public benefit:

Mobility 4 All is a start-up transportation management company whose mission is to provide high quality, safe transportation for seniors and people with disabilities. The lack of accessible and reliable transportation can leave people with disabilities and ailing older adults isolated from their communities and limit their ability to work, access healthcare and engage in other daily activities. Unlike traditional ride hailing services offered by Uber and Lyft, our target riders can not settle for corner to corner service, but expect and at times require door thru door and hand to hand service. We achieve this by only allowing well-trained drivers that pass our comprehensive fingerprint background checks and vehicle inspections to join our network. In addition, we offer riders and their caregivers the ability to choose favorite drivers and multiple ways to get a ride, including through our mobile app, website and call-in center. Our long term vision is to integrate and leverage self driving vehicle technologies that are universally designed to give seniors and people with disabilities mobility independence.

(B) The extent to which and the ways in which the corporation has created general public benefit include:

Mobility 4 All is a 21st century transportation solution that leverages a distributed ride matching platform tailored to serve riders that expect and need a higher level of service. In calendar year 2017, we created general public benefit through our involvement with the Self Driving Coalition for Safer Streets, a national advocacy organization championing the development and implementation of self driving vehicle technologies in the US. Mobility 4 All executives attended Self Driving Coalition for Safer Streets monthly conference calls and periodic meetings to support policies and practices that advance awareness of self driving vehicle technologies. Mobility 4 All executives also actively participated on the Metropolitan Council's Metro Mobility Task Force, which was created in statute by the 2017 state legislature to identify options for reducing paratransit program costs and improve efficiency.

(C) Any circumstances that hindered efforts to pursue or create general public benefit?

The cost to develop a network of drivers and users of special transportation is high. While the opportunity to harness web-based technologies to create general public benefit is significant, our target user base are less likely to have a smartphone and use mobile apps relative to the general public. In addition, the insurance industry is challenged to appropriately assess the risk associated with our technology platform and service, which results in higher than expected insurance premiums and deductibles.

(3) If the report is the first delivered for filing by the general benefit corporation, explain how and why the board chose the third-party.

The B-Labs Impact Assessment was chosen as it is an industry leader for 3rd party evaluation frameworks for this type of business and was highly recommended by other Minnesota-based general and specific benefit corporations.
