Music Mayhem is a for-profit corporation organized for the purpose of developing and selling its proprietary music guessing game and any related products and services. Our company's specific benefit purpose is to financially support research, advocacy and high quality care for individuals with Alzheimer's and related dementias. Our social mission is to make Alzheimer's a distant memory, one song at a time. To fulfill its purpose, the company donates a portion of proceeds from sales of its products to qualified organizations no less frequently than annually. The corporation will also donate products and services to organizations dedicated to Alzheimer's disease research, care and/or advocacy.

#3 SBC Statement

The company was not profitable in 2017 but was still able to donate a portion of their sales receipts from their live performances to our designated specific benefit, Alzheimer's and related dementia research, advocacy and care.

We donated \$285 (check #5177) on October 7, 2017 to the Association for Fronto-Temporal Degeneration http://www.theaftd.org Also, we donated our time and use of the game as entertainment at the group's fundraiser event on that same date.

The company also donated several volunteer performances to Augustana's Open Circle Adult Day Services program at 1015 N 4th Ave, Minneapolis, MN 55405 at a \$200 value for each. We also donated a copy of our board game (\$30 value).as a prize at these events and at several of our other live performance events throughout the year.
