M.R. 8210.0050: All mail voting envelopes must bear a legend indicate the ballot category enclosed, in no smaller than 8-point type. The ballot category is " mail "

M.R. 8210.0600, subp. 3: Printing Specifications

- Statement is to be printed on the back of the envelope
- Voter certificate must be at least 4-1/8 inches wide
- Area for voter's name and address must be no smaller than 1-1/4 inches by 3-1/4 inches
- Following text must be printed in no smaller than 12-point bold type:
  - " Voter must complete this section "
  - "Witness must complete this section"
- "X" on signature line must be at least 20-point type
- Remainder of the statement must be printed in no smaller than 10-point medium type

M.R. 8210.0710, subp. 1: The secretary of state shall provide samples of the front...of the envelope.

M.R. 8210.0710, subp. 2: Form

- Envelope must be white in color with black ink
- The following must be printed on the same side as the voter's certificate:

"For Official Use Only
