# Ecotone Analytics GBC Minnesota Annual Benefit Report 2019

This report certifies that the Ecotone Analytics GBC Board of Directors has chosen the B-Lab Impact Assessment as the third-party standard for Ecotone Analytics GBC, pursuant to clause (2), item (i). The board has also determined that B-Lab, the organization that has promulgated this third-party standard is indeed independent. The board has approved the report, with regard to the period covered by the report (calendar year 2019).

#### Ecotone's Creation of a General Public Benefit

(A) How the corporation has pursued general public benefit:

Mission: Ecotone Analytics GBC is a data analysis and communication company working exclusively with clients who want to measure, manage, and communicate their social or environmental impact.

Vision: Ecotone Analytics GBC is committed to expanding the use of social and environmental metrics in decision making for corporations, government, funders, and non-profits.

(B) The extent to which and the ways in which the corporation has created general public benefit include:

In calendar year 2019, Ecotone Analytics GBC helped create general public benefit through the following projects:

All Square 501(c)(3) - Worked with Founder and staff to update Social Return on Investment (SROI) calculation and define Logic Model based on 1<sup>st</sup> year of operation. We also formatted the update findings into an Impact Overview, a 4 page graphicly focused brochure, allowing for clear and easy communication of value to their funders and stakeholders.

Better Futures Minnesota 501(c)(3), - Northwest Indian Community Development Corporation 503(c), and the University of Minnesota-Duluth's Natural Resources Research Institute (NRRI) - Ongoing work with Better Futures' and NWICDC staffs to collect and analyze data under a grant from the Minnesota Environment and Natural Resources Trust fund (ENRTF), and the Legislative-Citizen Commission on the Management of Resources (LCCMR). The project piloted in 2016 and 2017 was renewed in 2018 thru July 2020. Continuing to be centered around the environmental impact of "deconstruction" (the systematic disassembly of a residential house), as an alternative to traditional landfill-based demolition. Ecotone collected and analyzed data and provided the stakeholders with environmental impact reports for all of the jobs under the ongoing program. Ecotone also worked with NRRI to do deeper analysis of the air, water, and health effects of the projects. With a further focus on leakage into groundwater from construction waste sent to landfill in the 2018 thru 2020 project.

Better Futures Minnesota 501(c)(3), - Updated the SROI research/data and reformatted the findings into the Impact Overview from original impact project in 2017.

Alia 501(c)(3) – Conducted impact analysis on the effectiveness of Kinship Care as an alternative the current foster care system. Resulting in a better report on what data and research still need to be collected on this more innovative family intervention. Allowing Alia to communicate their need for academic partnerships and further describe their "unsystem" to Foster care agencies across the United States.

Twin Cities Rise! 501(c)(3), - Conducted an Impact Analysis and SROI calculation of their workforce empowerment and

training programs. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders. For this project Ecotone also analyzed years of participant data in order to find key indicators of success.

Minnesota Homeownership Center 501(c)(3), - Conducted an Impact Analysis and SROI calculation of their Foreclosure Prevention and Homeownership training programs, as well as the network effects of their franchised online classes. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders. For this project Ecotone also analyzed years of participant data in order to find key indicators of success.

Transend IT 501(c)(3), - Conducted an Impact Analysis and SROI calculation of their IT Help Desk and networking training programs. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis.

Binary Bridge, SBC - Conducted an Impact Analysis and SROI calculation of their mobile and rugged Electronic Medical Records system. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders.

ServeMN 501(c)(3), - Conducted an Impact Analysis and SROI calculation of their Math Corpse elementary school math readiness training program. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders.

MoneyVerbs, Social Enterprise - Conducted an Impact Analysis and SROI calculation of their financial literacy app. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders.

Sustainable Conservation 501(c)(3), - Conducted an Impact Analysis and SROI calculation of their Managed Aquifer Recharge and Manure SDI programs. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis.

Granite Equity, Private Equity Fund – Consulted on the potential impacts of their portfolio companies and ran an educational workshop for leadership team about impact measurement.

Minneapolis Foundation, Donor Advised Fund, - Conducted an Impact Analysis of the potential impacts of the final grantees of the One MPLS Fund Housing round. Worked with the leadership team throughout the process to help them adjust strategy and become fluent in impact analysis. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders.

Finnovation Fellows, Social Enterprise Accelerator, - Ran an educational workshop for 5 fellows (Social Enterprise startup founders) on the impact landscape and measurement options. Also consulted individually with fellows about the potential impacts of their business models how to adjust strategy to optimize for impact.

Research and development- Continued developing and solidifying measurement and reporting methodologies to better communicate the social and environmental impact for enterprise actions to their stakeholders. Working with the Impact Management Project, a global group of impact reporting practitioners creating a common industry wide standard framework for measuring impact. Using this understanding, Ecotone has advocated for and educated the use of impact measurement methods within the Minnesota Social Enterprise space. Creating a more transparent and accountable standard of impact for all social enterprises and impact investors. As well as continuing to employ two researchers

providing career opportunities and work experience for the next generation of impact reporting workforce.

(C) Any circumstances that hindered efforts to pursue or create general public benefit?

Social and environmental impact measurement and due diligence for impact investment continues to emerge as a structural piece of impact generally but still remains in the early adopter stage of growth. Due to this continued slow adoption of the industry, we are still testing market fit and pricing models. Though we've now moved to building a pipeline of projects as opposed to product development. As more case studies and general awareness of social impact measurement permeates the business culture at large, we see an opportunity to help funders and organizations make better impact choices with their money.
