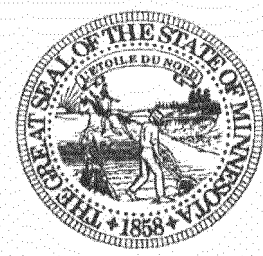

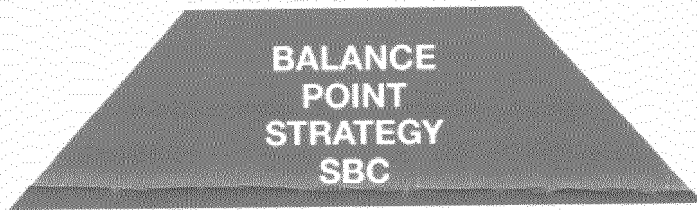

History of Balance Point Strategy

Balance Point Strategy, SBC (BPS) was incorporated as a Minnesota Public Benefit Corporation on April 21, 2017. The founders of BPS share a desire to assist public entities in improving the management and operations of their employee benefit programs. The founders believe that BPS analytical processes and observational model will result in improvements to the management practices in public entities, particularly as it relates to employee benefit programs.

BPS goal is to pursue the specific public benefit purpose of advocating for, and supporting continuous improvement of management and operations in public sector organizations. To this end, BPS focused most of its time during 2019 working on its Alpha Client *Annual Strategy Review (ASR)* in addition to beginning work with a Beta Client near the end of 2019.

Pursuit of our Mission

Regarding the period covered by this third report, January 1, 2019 through December 31, 2019, BPS pursued and achieved the specific benefit purpose stated in its articles of incorporation, and the BPS Founders believe BPS was successful in creating and developing its Alpha Client *Annual Strategy Review (ASR)* Model. This fresh, new, and unique analytical model provides an extensive quantitative review, incorporating data from several, client selected, peer group public school districts. Qualitative analysis for the Alpha Client included measurement of perceptions of employee health plan performance based on stakeholder perspectives and an analysis of the health plan's alignment with the client's over-arching strategies and goals.

Preliminary results of this Alpha Client's initial review were delivered to a Minnesota public school district during the prior year. Final results of the second review were shared with the school district's management team and the School Board Finance Subcommittee during early 2019. Throughout most of 2019 BPS was testing market appetite for its *ASR product*. In late 2019, BPS focused on its first annual Beta Client *ASR* and began preparation for a third annual Alpha Client *ASR*.

We believe Balance Point Strategy, SBC was successful in achieving the goals of our specific benefit purpose in the following ways:


BPS was able to successfully accomplish its Alpha Client model development; test the methodology; and implement this methodology in a Minnesota Public School District, resulting in the completion of a second Annual Strategy Review for a Metropolitan School District (affecting the experience of over 700 participating employees and 1,400 health plan participants). BPS plans to serve additional public school districts in the future, supporting the continuous improvement of our Public Entity Clients' Employee Health Plans.

BPS founders set no limit on the scope of our work to help public entities improve their management practices. As a result, the founders also donate hundreds of hours mentoring new school district personnel, providing guidance and advice, and assisting Minnesota school districts directly and through various professional organizations.

Balance Point Strategy, SBC did not encounter any situations or circumstances that hindered its efforts to pursue and support continuous improvement of management in public sector organizations.


