<u>Stated Mission</u>: To create commercial products from existing food waste rather than from new resources, in order to preserve the natural environment for the benefit of current and future generations.

The ways in which the corporation pursued and created the specific public benefit stated in its articles: The Covid-19 pandemic hampered production and sales efforts. Most of the corporation's work in 2020 was devoted to research and development of new products made with (a) upcycled spent grain that was recovered from Twin Cities breweries and distillers, and (b) egg shells from large egg-breaking operations.

The extent to which that specific public benefit purpose was pursued and created: As a founding member of the Upcycled Food Association, NETZRO engaged in customer and nutritional research studies to determine the value of its upcycled spent-grain products. NETZRO also worked on enhanced communications to promote the use of upcycled ingredients with various food and beverage companies.

Any circumstances that hindered efforts to pursue or create the specific public benefit: Though NETZRO did produce small quantities of products in 2020, the need for capital continued to be a challenge and a factor that has slowed the company's progress.
