La Dona Cerveceria Public Benefit Report March 17th, 2022

La Dona Cerveceria operated as a specific benefit corporation in 2021 for our 4th year. Our articles of incorporation describe our specific benefit as "supporting the Latino community of Minnesota and providing support to social, economic and environmental issues that affect the larger community." In support of this mission this year we supported local charities with small donations of products for silent auction, and nearly \$12,000 in direct donations. We hosted and sponsored an outdoor festival engaging the Latino community which was host to other local Non-profits and a vaccine distribution event. We also have been supporting Latino businesses by hosting monthly craft markets.

We were hindered in our pursuit of our specific purpose due to the COVID-19 Pandemic and resulting government shutdown, and occupancy restrictions. Our operations were significantly reduced until May 29th. Once restrictions were lifted regarding occupancy, we were still considered to be on the front lines of pandemic management by having to enforce mask mandates for most of 2021. Despite these obstacles, we were able to sustain our business and provide a meeting space and hub for the Latino community during our Dia de los Muertos Festival. We hope to continue to grow that festival and others celebrating Latino heritage and culture. As well as supporting the variety of Latino businesses we partner with to do those events.
