

SACRED CLAY COUNTRY INN, GBC

Sacred Clay Country Inn operates as a General Benefit Corporation.

In 2015, Minnesota passed legislation that created the "Benefit Corporation" thereby joining 34 other states with similar statutes. A benefit corporation is, in a sense, sort of like a non-profit on steroids. A benefit corporation is still in the business of creating value and paying profits to its shareholders – but only when its stated benefit to society has been met. The social purpose of the benefit corporation trumps the creation of profits as the chief goal.

Thus, I recently formed a General Benefit Corporation – the Sacred Clay Country Inn GBC. The purpose of this corporation is to:

- Increase the well-being of Sacred Clay guests by relieving stress from their lives (the Social Benefit).
- To create a modest financial return to the shareholders (the Financial Benefit).

Since August 2021, I've asked guests if they'd give me feedback on how well I'm doing with regard to the Social Benefit – relieving stress.

Most guests left me feedback. One hundred and two (102) of you filled out my survey.

I asked everyone to rate their stress level when they arrived and to also rate it when they were ready to depart.

Here is the feedback I received.


On Arrival: Low Stress Level (1.1 on a 9-point scale)

 Stress level remained low (thank goodness, I didn't increase their stress level!). Still at 1.1 when they left Sacred Clay.

On Arrival: Moderate Stress Level (4.5 on a 9-point scale)

• Stress level fell to 1.7 when they left Sacred Clay.


Moderate Stress Level Upon Arrival
