R&D LABS has pursued general public benefit with reference to B-Lab's independent third-party standard, Impact Assessment, by identifying and researching global problems and solutions for sustainable development as well as how to maximize net-positive impact. B-Lab's Impact Assessment is being applied in a manner consistent with the application in prior reports.

Their activities that correlate directly with B-Lab's Impact Assessment include reducing their footprint by reusing, recycling, and composting; installing energy efficient lighting and computing resources; improving the sustainability of their policies and procedures.

The main circumstance that hindered efforts to pursue or create general and specific public benefits was limited financial resources.

Regarding specific public benefits, R&D LABS identified and researched:

- facilities and businesses to acquire, which are intended to generate revenue used for funding sustainable development. Letters of intent were submitted for a portfolio of facilities as well as a business that included a facility more capable of supporting sustainable development projects.
- methods to obtain required results. The first stage of the vertical agriculture program continued to monitor variables.
- different approaches to increase both solar power systems and waste to energy applications. The sustainable architecture project progressed with the fabrication of proof-of-concept models of key components.
- the acquisition of facilities and businesses in related industries. Letters of intent were submitted
 for a portfolio of facilities that would have made a positive impact on the energy, transportation,
 recycling, and housing industries.
