- 3. List Initial Registration Number if applicant is filing a renewal oramendment.
- 4. Provide a complete street address for the Principal Place of Business.
- 5. The application form must be signed by the applicant and notarized. If the applicant is an entity, the registration form must be signed by an authorized representative of the entity.

Initial Registration: The initial registration form must be completed and submitted to the Secretary of State's office along with a sworn certification of surety bond.

Filing Fee for the initial registration application is \$700 payable to the Minnesota Secretary of State.

Renewal Registration: The registration is renewable annually. The renewal application must be submitted to the Secretary of State's office, along with a sworn certification of surety bond.

Filing Fee for the renewal registration application is \$200 payable to the Minnesota Secretary of State.

Amended Registration: There is no fee for filing an amended registration.

Cancellations & PostJudgment Registrations: Standard forms are not available. Drafted documents are required. Include Registration Number from your initial registration letter on drafted document. Filing requirements for these registrations can be found in Minnesota Statutes, Chapter 549.35. There is no fee for filing a Cancellation or PostJudgment.
