

Mission

The Trade Center of the Americas (TCA) is a general public benefit corporation that promotes sustainable and inclusive economic growth by fostering international trade and investment opportunities for women and minority owned businesses, small and medium size companies and startups across North, Central and South America.

In order to make our business model sustainable, a percentage of our profits are allocated to support women owned startups and women entrepreneurs.

Vision

In partnership with the Minnesota business community, our vision is to become leaders on bridging the geographical and cultural gaps between the Midwest and the rest of the Americas and vice versa. At the Trade Center of the Americas, we aim to connect our members by developing business opportunities through establishing personable business connections across the regions.

We leverage our cross cultural and trade expertise in order to increase the to help build an inclusive and sustainable trade and investment ecosystem.

Values

The TCA's values are integrity, diversity and inclusion, sustainability and innovation. It was established on the principles of the United Nations 2030 Sustainable Development Goals:

Four Pillars of Our Business Model

Our four pillars of our business model are built to establish a community of trade actors by establishing the relationship and connecting them through:

- Four membership levels supported by a digital data platform that provides networking opportunities and business interconnectedness across regions.
- Cross-cultural business coaching, mentorship and consulting opportunities
- Matchmaking referrals to our members
- Public-Private-Partnerships (PPPs) established to facilitate open and transparent dialogues, between local and foreign governments, public and private sectors, corporations, grassroots organizations and all trade actors in the region.

These pillars are designed to build a diverse and inclusive international trade community based on trust, integrity, respect for diversity, innovation and sustainability.

2023 Goals and Accomplishments

January- March 2023

The TCA signed an agreement with tropical fruit and malanga producers from Manabí-Ecuador, to provide technical assistance to a local community of dragon fruit producers. The goal was to provide the WeFairTrade Academy certification to every participant, including women and men working in the farms and in the field. We were also able to prepare a thorough SWOT analysis for the tropical fruit and malanga producers' community. This allowed us to prepare and customize the 2023 fair trade-business development plan for this community.

March-June 2023

Silvia Ontaneda, our CEO, traveled to Ecuador to work on the WeFairTrade Academy. As a result, the following goals were accomplished:

- 1. Provide community-business organizing strategies to producers based on sustainabile development and gender inclusive practices.
- 2. Establish a legal organization for the 200 families participating in the program
- 3. The Alianza Solidaria del Ecuador was legally registered in Ecuador
- 4. The Alianza Solidaria executive committee is mostly women
- 5. Co-develop (community with the support of the TCA) a comprehensive business plan

June-September 2023

- Provide training, mentorship and coaching to the members of the Alianza Solidaria del Ecuador: women, young women and young men on the building sustainable and environmentally ecosystem
- 2. Recruit bi-lingual professional from Pepsico and General Mills to provide technical assistance to the farmers of the Alianza Solidaria

September-December 2023

The last phase of the WeFairTrade Academy was developed during this period of time:

B

- 1. Continued coaching, mentorship and training opportunities to the Alianza Solidaria members (Coop dragon fruit, tropical fruit producers)
- 2. Provided tech assistance to the farmers
- 3. Conduct cross-cultural leadership forums with the Alianza Solidaria members
- 4. Closing ceremony with Graduation Certificates of the WeFairTrade Academy to participants from the Alianza Solidaria

The TCA continues to pitch to social impact investors in order to procure funding to scale.

The WeFairTrade Academy, a product of the TCA, has been legally established and a Trademark has been applied to protect the IP rights.

Executive Summary:

The TCA has proved to be a successful economic and social impact business model.

2023 was an important year for us because we were able to implement the WeFairTrade academy syllabus as a product of the TCA. We have developed a 12-module bilingual, bicultural curriculum based on the principles of the 2030 United Nations Sustainable Development Goals. In addition, the WeFairTrade Academy has issued 200 certifications to the 2023 participants: the Alianza Solidaria Coop, an Ecuadorian organization formed by women and men from the rural areas of Ecuador.

The TCA continues to work and pursue funding opportunities through public-private-partnerships and/or investors in order to be able to expand in other countries in Latin America and to continue to expand services among Latin American entrepreneurs in the US.

In addition, the TCA is also connecting the producers and farmers directly with importers and distributors in the USA in order to provide matchmaking-business opportunities. Such is the case with the dragon fruit/malanga and other products of the Alianza Solidaria Coop in Ecuador.

In 2023, Social Enterprise Impact showcased the Trade Center of the Americas in the bi-annual Social Enterprise Impact Showcase for the local and global impact in the fair-trade arena and the impact of the business model in the global economy.
