  - (i) The identity of the third-party standard determined by the Board is as follows:
    - B Impact Assessment, which is provided by B Lab, 15 Waterloo Ave., Berwyn, PA 19312
  - (ii) With reference to that third-party standard:
    - (A) The corporation has pursued general public benefit in the following ways:
      - providing programming and consulting services to individuals involved in the criminal justice system, post incarceration, in an effort to reduce recidivism among the criminal offender populations;
      - contracting with the Minnesota Department of Corrections to provide cognitive behavioral programming to individuals releasing from Minnesota prisons who have a high or very high risk level for re-offending, in an effort to reduce recidivism among the criminal offender populations; and
      - contracting with the Minnesota Department of Corrections to provide cognitive behavioral programming to individuals released into the Bridge Work Release program, in an effort to reduce recidivism among the medium risk criminal offender populations; and
      - offering one-on-one personal cognitive behavior programming designed to alter the way criminal offenders think and behave, in an effort to reduce recidivism; and
    - (B) The extent to which and the ways in which the corporation has created general public benefit include:
      - education about cognitive behavioral programming has been provided to men incarcerated in Stillwater prison who are awaiting release from incarceration;
      - education about cognitive behavioral programming has been provided to women suffering from trauma who are coming out of domestic violence, homelessness or chemical dependency
      - education about cognitive behavioral programing has been provided to colleagues in the criminal justice community at annual conferences; and
      - evidentiary measurements confirm the success of our programming content in reducing recidivism.


(C) Circumstances that hindered efforts to pursue or create a general public benefit, if any, include:

- The corporation experienced challenges in marketing programs and services to potential referral sources and finding nonprofit entities with whom to partner.
