#### Introduction

Professional Data Analysts, GBC (PDA) provides program evaluation, statistical consulting, and custom web development services to move public health initiatives forward. We are headquartered in Minneapolis, Minnesota, and work in several states across the US.

Throughout 2024, PDA worked to create positive social impact for our staff, clients, community, and the environment.

#### **Staff**

PDA strives to foster an inclusive environment where every individual has the resources and opportunities they need to grow, thrive, and succeed. We offer exceptional benefits, a casual and flexible work environment, and professional development opportunities. We also pay all employees at least the living wage for a family. In 2024, we strengthened our support for staff in a few key ways.

#### **Staff Connection**

In the post-pandemic world, we continue to focus on keeping our staff connected and engaged. About one quarter of our staff are remote and work from their homes full time. In order to keep them from feeling isolated, we incorporate many touch points throughout the work week. During meetings, we take a few minutes at the beginning and end to connect on a personal level. We also utilize Zoom channels to share updates about our lives, kids, pets, etc. Supervisors

check in with their staff at least weekly and project teams meet regularly. In 2024, we hosted virtual game breaks and a virtual end-of-year get together.

Throughout the year, we supported staff connection for our in-office staff through lunches, ping pong and video games, and walks. We continued our staff newsletters, which we use to share company and project updates, highlight accomplishments, and introduce new staff.



#### **Celebrating Milestones**

During 2024, a few staff celebrated major work anniversaries such as 5, 10 or even 20 years. We recognized these important accomplishments in a few ways. First, we included a shout out in our staff newsletter to highlight the individual's impact at PDA over the years. We also sent a virtual card that was signed by many of our staff where they wrote personal notes about why they enjoy working together. For our local staff, we treated them to a team lunch or happy hour. For remote staff, we sent a meaningful gift. PDA is fortunate to have many long-term staff who enjoy working here and add significant value to our clients and company.

**Mental Health Support** 



Our Mental Health and Wellbeing
Committee, which was formed in 2022,
continued planning events to support staff
mental health this year. This included a
focused two-week period in March with
events ranging from virtual bingo to yoga,
board games, creative activities and an open
conversation about mental health and
resilience. The focused period ended with a
day off for all staff. This allowed staff to take
time for themselves to do any activities that
best support their mental health and

wellbeing. Staff reported feeling less guilty about completely unplugging during that time because their co-workers were off as well.

The committee also planned events throughout the year, such as outdoor walks and online games to encourage staff to take breaks from work.

We offer a ping pong table and treadmill desk in our office to encourage staff connection and physical activity even during the winter.

#### **Professional Development**

In 2024, we improved our annual review process and allowed staff to provide anonymous feedback to Directors. This gave staff an opportunity to openly share any issues on their mind and provided Directors with an opportunity to improve the way they work with others.

We encourage and support professional development throughout the year. We support staff attendance at conferences and encourage publications when appropriate. We also offer internal opportunities, such as our Data Visualization group that meets regularly to discuss new tools and tips. Additionally, we encourage sharing knowledge with each other through several Zoom channels dedicated to topics such as tobacco evaluation and data analysis. Earlier in 2024, we held a staff meeting in which we had an open discussion about Al and how it could be utilized at PDA.

Challenges: While we are working to improve our delegation on client projects, we find that a few staff still carry a large burden in terms of leading projects. Sharing leadership responsibilities on projects would lessen the burden and help other staff grow.

#### **Clients**

PDA pursues public benefit in Minnesota and across the country by providing program evaluation, statistical consulting, and software development to clients whose programs seek to

improve the health and wellbeing of individuals and communities. We work with government agencies, universities, medical institutions, and non-profits to assess and improve their programs. We are committed to delivering objective, high-quality data and innovative, cost-effective solutions to clients. Our work is focused on tobacco cessation, chronic disease prevention, behavioral health, and other public health topics.

We proudly served **23** clients across **13** states in 2024.

- ✓ We take care to ensure we only work with clients and on projects that aim to produce or increase public benefit. We will never work with clients who sell tobacco products, participate in gambling, or cause unnecessary harm to the environment.
- ✓ Our evaluations support underserved populations by helping our clients increase their reach and service to people of color, people living on low incomes, those that are uninsured or underinsured, those with limited education, and other priority groups within their public health programs. We emphasize the importance of prioritizing these populations and reaching them through client health equity initiatives.
- ✓ Our staff partner with clients to present at conferences and publish peer-reviewed articles on public health topics, living our value of Excel Together.
- ✓ In 2024, a few team members attended a statewide tobacco meeting and conducted site visits with the centers delivering tobacco cessation services in Florida. We presented an overview of evaluation in the tobacco control field and designed activities to gauge the perceptions of evaluation and evaluation needs. We also collected feedback that we'll use to improve the application we built for Florida



Challenge: One of our goals is to apply our expertise in tobacco cessation to the opioid epidemic. We have found that many opioid related projects do not include an evaluation budget so it's been a challenge to find opportunities to work in this area.

## Community

PDA is an avid supporter of our local community. Each year we contribute to the community through volunteerism, company financial donations, staff donation matching, and pro bono work. We support organizations that help our most vulnerable neighbors and advocate for social justice.

In 2024 we supported our community in a few primary ways:



- ✓ Hired two evaluation interns. We strive to give opportunities to those from marginalized or underrepresented communities and give them the tools and experience they need to be successful in the field of evaluation. Both of our interns continued working at PDA after their initial internship term.
- ✓ Continued our community giving program, which allowed staff to donate to any eligible non-profit organization and have their donation matched by PDA. This resulted in donations to 12

organizations totaling several thousand dollars.

✓ Completed multiple service projects including prepping and packing food for critically ill Minnesotans with Open Arms, distributing fresh produce to the local community with Neighborhood House, and hosting a food drive with NorthPoint Health & Wellness.







## NORTHPOINT Health & Wellness Center

- ✓ Became a member of the Minnesota Black Chamber of Commerce to better support Black-owned businesses in Minnesota.
- ✓ Donated to the New Impact Fund, a nonprofit composed of philanthropic leaders who want to invest in and with Black, Indigenous, Latino, Asian, and Immigrant business owners in underinvested Twin Cities neighborhoods. The donation supported multiple local, people of color owned businesses. Additionally, PDA's President serves as an advisor to this nonprofit.

- ✓ Donated to organizations which advocate for marginalized communities, such as Planned Parenthood, ACLU, GLAAD, the Link, and International Institute of Minnesota.
- ✓ Supported local BIPOC artists by purchasing their artwork to hang in our office.
- ✓ Bought local. When ordering lunches for staff, hosting happy hours, or giving gifts to staff, we patronized local, people of color owned businesses.

Challenge: As we hire more staff outside of Minnesota, our definition of local changes. PDA remains committed to supporting the Minneapolis community but must also provide staff with opportunities to support their home communities.

#### **Environment**

As a Certified B Corporation, we include the environment as one of our stakeholders and make every effort to minimize our impact. In 2024, we continued many of the practices we followed in previous years.

- ✓ Maintaining carbon neutrality by purchasing carbon credits from Green Cities Accord, a non-profit organization in Minneapolis that plants and maintains urban tree canopies
- ✓ Utilizing solar panels on our building
- ✓ Buying only 100% post-consumer recycled paper products
- ✓ Recycling paper, glass, cans, plastic, and e-waste
- ✓ Using non-disposable dishware
- ✓ Composting of food scraps, paper towels, and other items
- ✓ Supporting restaurants and catering companies that utilize local and sustainable farmers
- ✓ Using non-toxic and sustainable cleaning supplies and hand soap
- ✓ Offering bus pass reimbursement to staff to encourage use of public transport
- ✓ Offering onsite showers and indoor bike parking to support biking to work

Challenge: We are always looking for new and innovative ways to lessen our impact on the environment.

PDA strives to maximize positive social impact in our community and the communities we work in while minimizing our impact on the environment. We do this through our project work, choice of vendors, philanthropy, and sustainability efforts.
