Specific Benefit described in articles of incorporation:

Catalyst Books & Gifts, SBC provides a welcoming space for people to buy science-related books and gifts while promoting diversity, equity, and inclusion in science/STEM. The store will support minoritized scientists, artists, and writers, and change the culture of science and academia both directly and indirectly. The Corporation will pursue its mission directly through promoting works by BIPOC, disabled, LGBTQIA+, and other minoritized creators. The Corporation will pursue its mission indirectly by donating proceeds from sales to organizations working to diversify and decolonize STEM; dismantle racist, sexist, and ableist structures; and improve the culture of science and academia.

Annual benefit Report Requirements:

(1) with regard to the period covered by the report, a narrative description of:

(i) the ways in which the corporation pursued and created the specific public benefit stated in its articles Catalyst Books & Gifts pursued and created the specific public benefit stated in its articles in several ways during 2024. The most prominent was through featuring books on its website and in-person events that support the mission of promoting DEI in STEM and supporting works by minoritized creators, including rotating website content several times throughout the year in categories of Featured, Kids, New Release, and Available for Pre-Order. Finally, the company's social media accounts were used to regularly amplify messages related to the specific benefit mission of the company. The semi-permanent, self-service "pop-up" location that was founded in 2023 continued within the Signature Arts Building. Two in-person sale events were held at Signature Arts, one in April and the other in December.

(ii) the extent to which that specific public benefit purpose was pursued and created Quantitative measures of the extent to which the public benefit purpose was pursued include overall sales interactions with customers (approximately \$5,000); amount of money raised for non-profit organizations (\$100 for FORSE, Fostering Opportunities & Relationships in STEM Education); exposure to new customers via in-person events; fostering the long-term pop-up at Signature Arts; and social media activity.

(iii) any circumstances that hindered efforts to pursue or create the specific public benefit
As the company was founded in June 2021 and continues to exist almost entirely online, one primary hindrance to pursuing the specific public benefit was simply the small scale and reach of the business. Another is the limited time available to pursue new efforts. Finally, the Signature Arts Building's infrequent opening hours limits the ease of access for customers to the pop-up location.

Goals for improvement in 2025 include:

- Continue social media engagement on BlueSky
- Continue recruiting additional Board members
- Continue relationship with Signature Arts through increased opening hours and in-person events
- Increase advertising for Bookshop.org affiliate page for additional revenue
